ARTICLES OF INCORPORATION

PURSUANT TO THE PROVISIONS OF THE ALABAMA BUSINESS CORPORATION ACT, THE UNDERSIGNED HERBY ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION.

- Article I* The name of the corporation is Oak Mountain Outdoor Products, Inc.
- Article II* The duration of the corporation is “perpetual”.
- Article III* The corporation has been organized for the following purpose:
To design, market, manufacture and sell outdoor recreation products or
any other activity that is legal.
- Article IV* The number of shares which the corporation shall have the authority to
issue is 1000.


