

LEGAL DESCRIPTION

Commence at the southwest corner of the northwest quarter of the northwest quarter of Section 12, Township 22 south, Range 4 west, Shelby County, Alabama and run thence N 89° 29' 09" E along the south line of said quarter-quarter a distance of 134.88' to a rebar corner on the easterly margin of Shelby County Highway No. 10 and the point of beginning of the property being described; Thence continue last described course a distance of 310.35' to a set rebar corner; Thence run North 00° 30' 52" W a distance of 314.94' ; Thence run S 89° 29' 09" W a distance of 434.52' to a rebar corner on the same said margin of same said Highway; Thence run S 22° 01' 53" E along said margin of said highway a distance of 338.53' to the point of beginning, containing 2.69 acres, more or less.
