KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Two Hundred Seventy Thousand Nine Hundred and 00/100 (\$270,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Premiere Homes, Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Michael W. Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

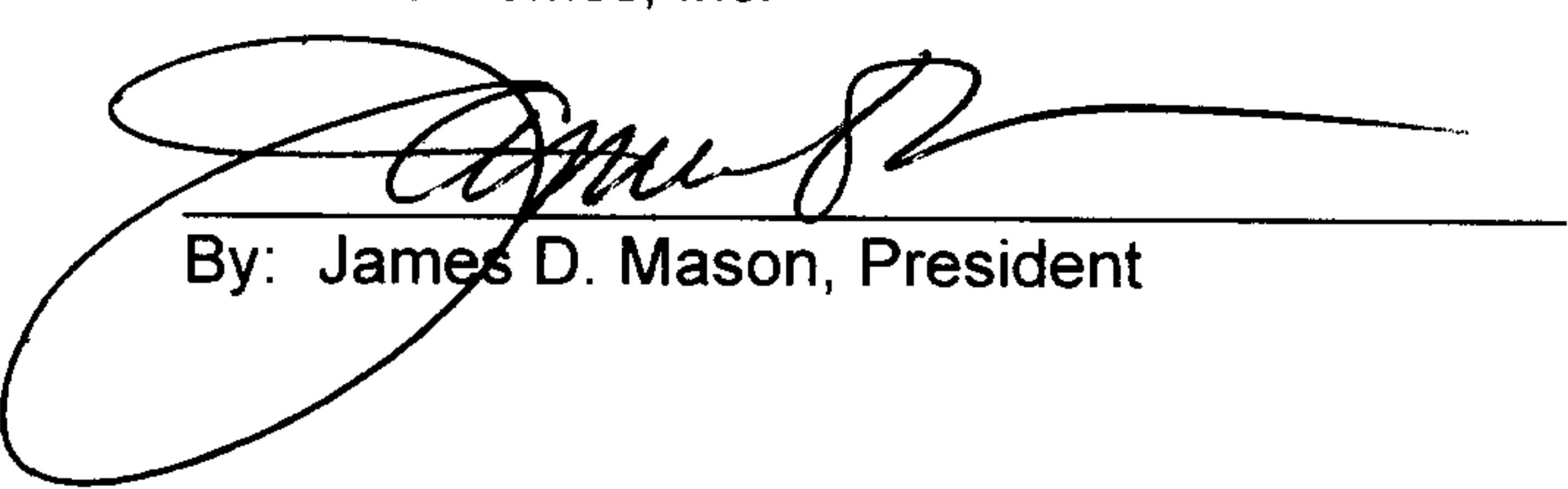
\$216,720.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.
