Know All Men by These Presents: That in consideration of **Two hundred ninety eight thousand one hundred forty and no/100 (\$298,140.00)** to the undersigned grantor, a limited liability company, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **StoneCrest Home Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Donald K. Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.


\$238,512.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.
