

CORPORATION FORM WARRANTY DEED
JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP

the Grantees named herein, the receipt of which is hereby acknowledged, the said Grantor does by these
presents, grant, bargain, sell and convey unto Charles R. Beech and Wendy W.
Beech, Husband and Wife (herein referred to as "Grantees") as joint tenants with
rights of survivorship, the following described real estate, situated in Shelby County,
Alabama, to-wit:


