Know All Men by These Presents: That in consideration of ONE HUNDRED TWENTY SEVEN THOUSAND and 00/100 (\$127,000.00) DOLLARS to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of which is acknowledged, we, WILLIAM CHRIS CALVERT, AN UNMARRIED PERSON (herein referred to as GRANTORS) do grant, bargain, sell and convey unto GEORGE BROOKE-POWELL and ELIZABETH BROOKE-POWELL, HUSBAND AND WIFE, (herein referred to as GRANTEES, as joint tenants, with right of survivorship, whether one or more) the following described real estate, situated in SHELBY County, Alabama, to-wit:
