

**ARTICLES OF INCORPORATION
OF
ADAMSMARK DEVELOPMENT, INC.**

A BODY CORPORATE

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, Mark Maloof, acting as incorporator of a corporation under the Code of Alabama, adopts the following Articles of Incorporation for the corporation:

1. The name of the corporation shall be **AdamsMark Development, Inc.**, and the corporation shall be authorized to operate under that name, use the trade name **AdamsMark Development, Inc.**, or use any other trade name not now being used by another person, firm or corporation.
2. The purpose for which the corporation is formed is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Alabama, including general construction and real estate development.
3. The location of the initial registered office of the corporation shall be 109 Royal Chase Drive, Pelham, Alabama 35124, and the name of its initial registered agent at that address is Mark Maloof.
4. The authorized capital stock of the corporation shall be one thousand (1,000) shares having a par value of One and No/100 (\$1.00) Dollar per Share.
5. The name and post office address of the incorporator is as follows:


