LEGAL DESCRIPTION

Parcel I:

A parcel of land situated in the SW ¼ of Section 12, Township 20 South, Range 3 West, City of Pelham, Shelby County, Alabama, and being more particularly described as follows:

Commence at the NW corner of the SW ¼ of the SW ¼ of above said Section, Township and Range; thence North 88 degrees 28 minutes 46 seconds East along the ¼ ¼ line, a distance of 1,823.23 to the point of beginning; thence continue along the last described course, a distance of 60.40 feet; thence South 01 degrees 52 minutes 20 seconds East, a distance of 93.90 feet; thence South 26 degrees 14 minutes 11 seconds West, a distance of 491.39 feet; thence North 65 feet 42 minutes 50 seconds West, a distance of 19.52 feet; thence North 24 degrees 17 minutes 10 seconds East, a distance of 154.69 feet; thence North 65 degrees 11 minutes 05 seconds West, a distance of 90.34 feet; thence North 28 degrees 45 minutes 38 seconds East, a distance of 394.77 feet to the point of beginning.

Parcel II:

A parcel of land situated in the SE ¼ of the SW ¼ of Section 12, Township 20 South, Range 3 West, Shelby County, Alabama, and being more particularly described as follows:

Commence at the NE corner of the SE ¼ of the SW ¼ of said Section, thence South 88 degrees 28 minutes 46 secondsWest along said ¼ ¼ line a distance of 486.61 feet to a point lying on the Westerly Right of Way of U.S. Highway # 31, said point being on the point of beginning; thence South 88 degrees 28 minutes 46 seconds West, a distance of 297.13 feet; thence South 01 degrees 52 minutes 20 seconds East, a distance of 93.90 feet; thence South 26 degrees 14 minutes 11 seconds West, a distance of 491.39 feet; thence South 65 degrees 42 minutes 50 seconds East a distance of 240.23 feet to a point lying on the Westerly Right of Way of U.S. Highway #31; thence North 24 degrees 29 minutes 50 seconds East along said Right of Way a distance of 704.74 feet to the point of beginning.
