Know All Men by These Presents: That in consideration of **One hundred thirty nine thousand nine hundred and no/100 (\$139,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Michael R. Barrett and Jaimee K. Barrett, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Michael K. Campbell and Dee Andrea Campbell** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Lot 15, except the West 5 foot, according to the Survey of Hamlet, Fourth Sector, as recorded in Map Book 9, Page 22, in the Probate Office of Shelby County, Alabama.

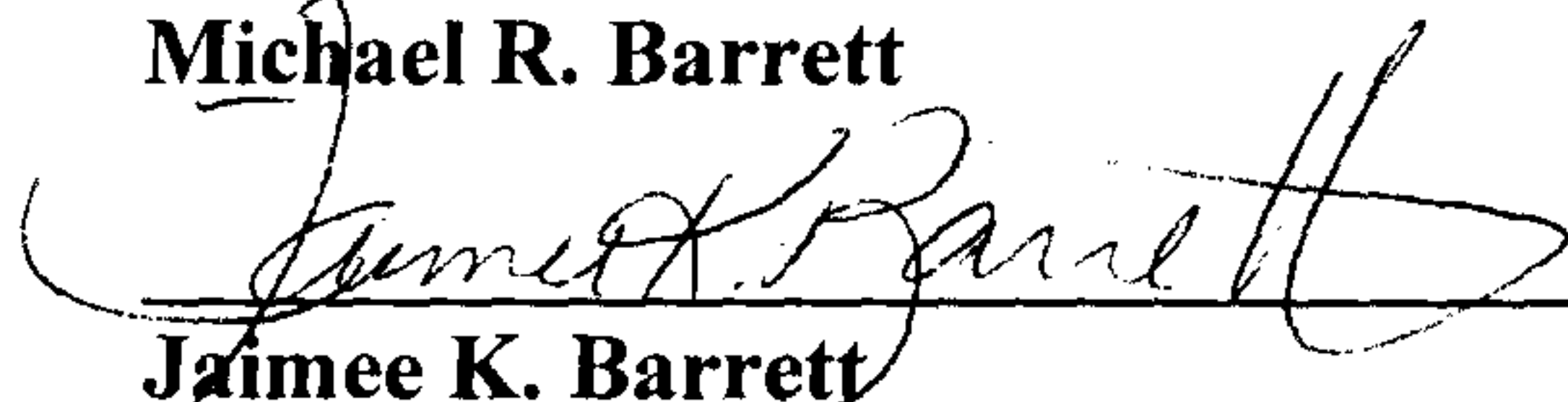
