SUBORDINATION AGREEMENT

STATE OF ALABAMA COUNTY OF SHELBY

This Subordination Agreement, made and entered into on this the day of MARCH, 2003, by and between COMPASS BANK, as Party of the First Part, and AMERICA'S WHOLESALE LENDER, ITS SUCCESSORS AND/OR ASSIGNS, as Party of the Second Part.

WITNESSETH

THAT, WHEREAS, SAMUEL N. ALFANO AND ROSEMARY A. ALFANO, has an outstanding loan in favor of COMPASS BANK, as set forth in INSTRUMENT #2002-18537, in the Office of the Judge of Probate of SHELBY County, Alabama on that certain real estate located at 5296 BIRDSONG ROAD BIRMINGHAM, AL 35242 to secure an indebtedness of \$52,540.00 and said lien is in full force and effect; and,

WHEREAS, SAMUEL N. ALFANO AND ROSEMARY A. ALFANO, to COMPASS BANK, recorded in the Probate Office of SHELBY County, Alabama in INSTRUMENT #2002-18537, shall be second and subservient to the mortgage of SAMUEL N. ALFANO AND ROSEMARY A.
