JUDGMENT AFFIDAVIT

COMES NOW Shane Jones, hereinafter designated as "Affiant", and after first having been duly sworn, said Affiant does hereby depose and say as follows:

- 1. That Affiant has personal knowledge of the facts stated herein, is over the age of nineteen (19) years, and is competent to execute this Affidavit.
- 2. Shane Jones is the sole proprietor of Jones Country Food Mart, situated in Shelby County, Alabama.
- 3. On or about November 16, 2000, Carolyn Boothe, as the Administratrix of the Estate of Russell Kristopher Adams, deceased, filed a lawsuit against Shane Jones, Jones Country Food Mart, Johnny Ray Roberts, et al., in the Circuit Court of Shelby County, Alabama, and said cause was designated by Case Number CV-00-1131.
- 4. On or about January 15, 2002, said Plaintiff obtained a judgment against Johnny Ray Roberts in the sum of \$1,500,000.00, plus court costs. Said judgment was recorded at Instrument Number 2002-09822 in the Office of the Probate Judge, Shelby County, Alabama. The recorded Certificate of Judgment is barely legible, as is noted by the recorder's memorandum, which indicates as follows: "At the time of recordation, this instrument was found to be inadequate for the best photographic reproduction."
- 5. Prior to the rendition of said judgment, legal counsel for Shane Jones and Jones Country Food Mart filed a Motion for Summary Judgment in regard to said cause; same having been filed with the Court on July 2, 2001. A certified copy of said Motion for Summary Judgment is hereto attached as **Exhibit** "A".
- 6. On November 15, 2001, the Court, Honorable Dan Reeves presiding, granted the Motion for Summary Judgment which had been filed on behalf of Shane Jones and Jones Country Food Mart. A certified copy of the Case Action Summary by which Judge Reeves granted Summary Judgment in favor of Shane Jones and Jones Country Food Mart is hereto attached as Exhibit "B".
- 7. Affiant affirmatively and positively states that no judgment was entered against Shane Jones or Jones Country Food Mart in reference to the above designated cause (CV-00-1131).
- 8. There are no judgments pending against Shane Jones or Jones Country Food Mart in Shelby County, Alabama, nor in any other country or state.
