30. Attached as Exhibit "A" is a copy of my original birth certificate.



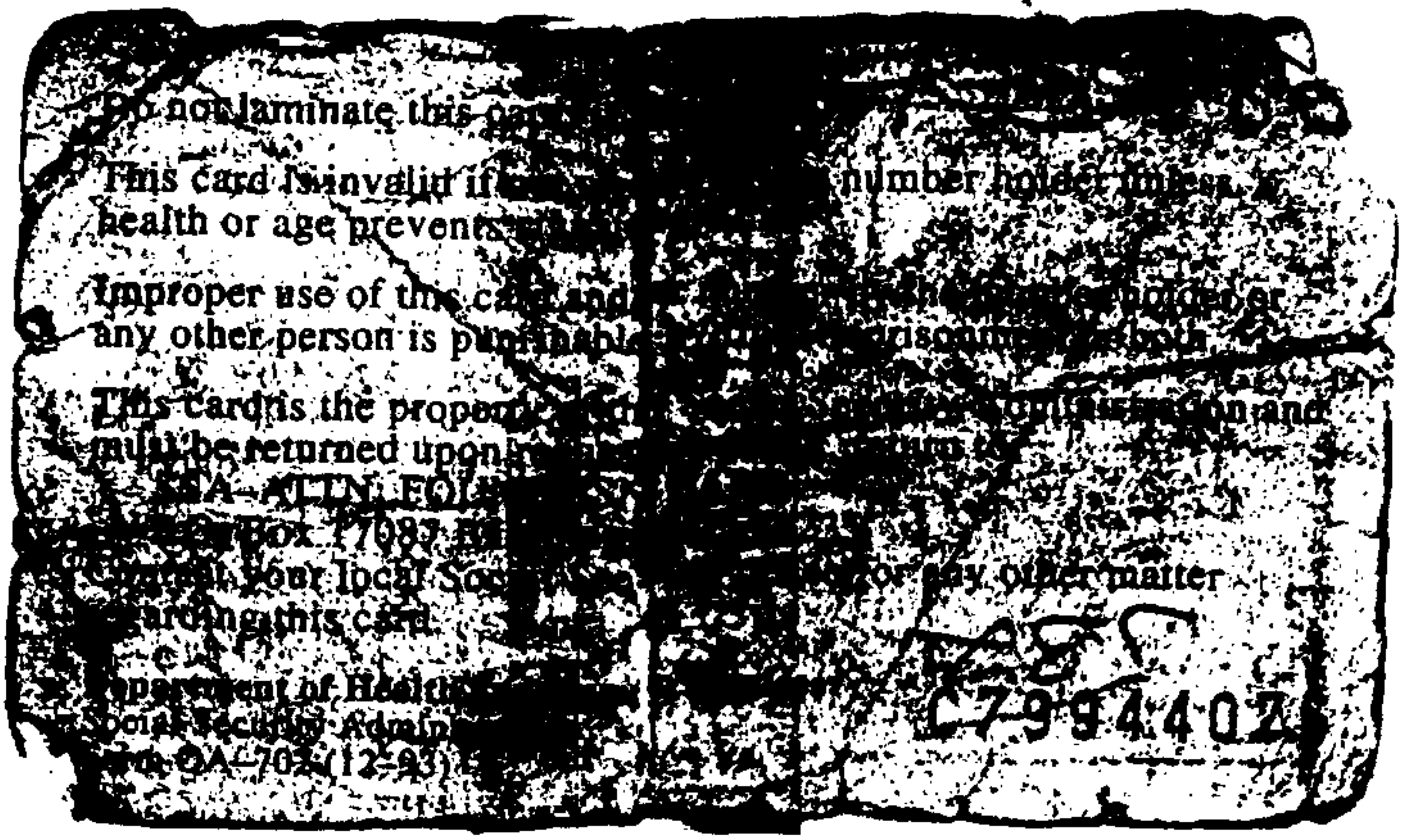
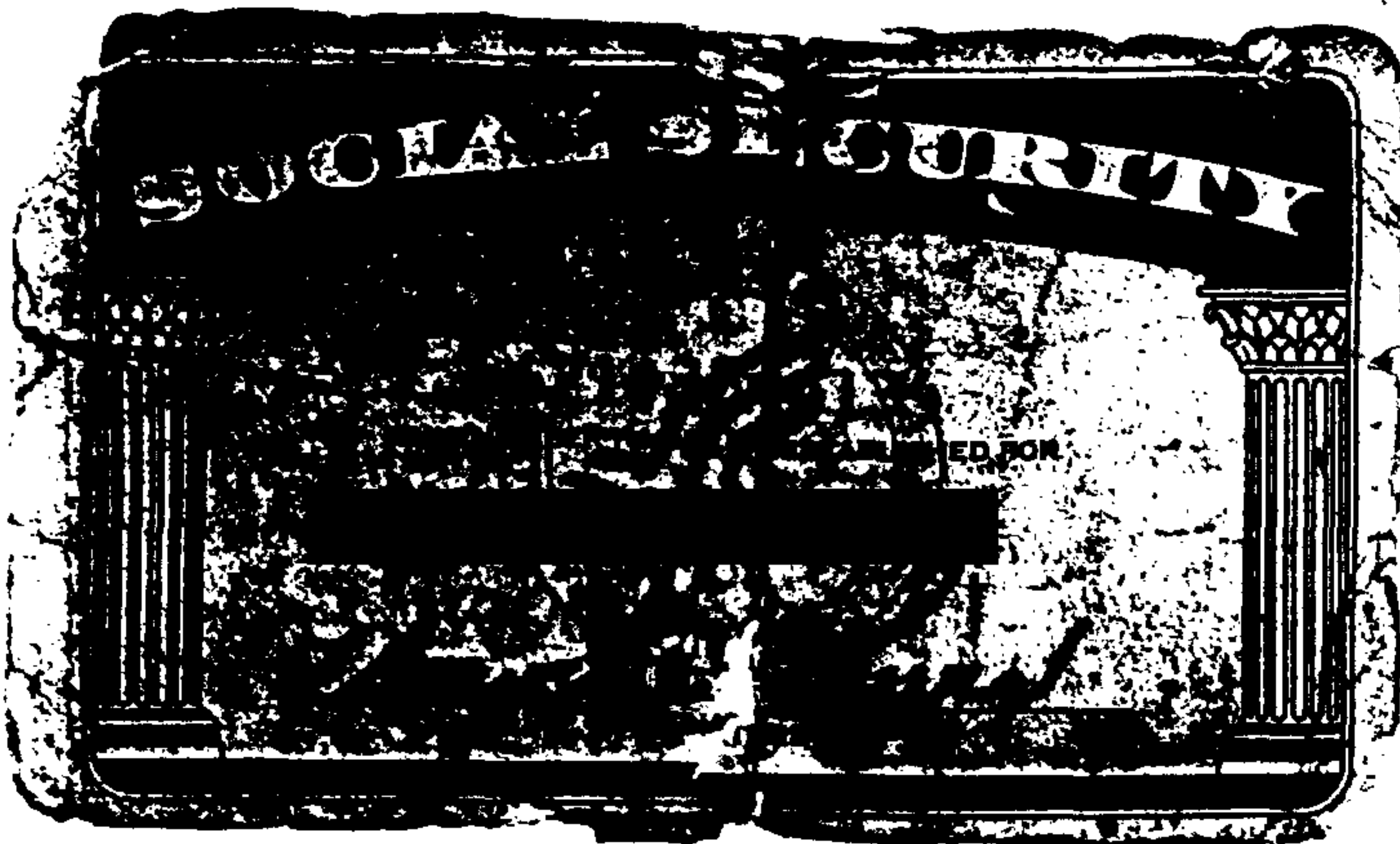
