

East a distance of 499.85 feet to the East right of way line of the Alabama Power Company Transmission Line; thence South 3 deg. 50 min. 00 sec. East along said right of way line for a distance of 648.42 feet to the intersection of the East right of way line of Alabama Power Company Transmission Line and the South right of way line of Shelby County Road No. 280 (formerly the old U. S. Highway No. 280 or Florida Short Route) for the point of beginning; thence continuing South along said line a distance of 1279.39 feet to a white and red painted line; thence South 81 deg. 09 min. 37 sec. East along said painted line for a distance of 724.98 feet; thence North 0 deg. 54 min. 03 sec. West a distance of 680.37 feet; thence North 0 deg. 35 mln. 50 sec. East a distance of 399.77 feet; thence North 88 deg. 11 min: 27 sec. West a distance of 154.80 feet; thence North 31 deg. 32 min. 04 sec. West a distance of 544.15 feet to the South right of way line of Shelby County Road No. 280 (formerly the old U. S. Highway No. 280 or Florida Short Route); thence South 65 deg. 53 min. 18 sec. West along South right of way line for a distance of 390.27 feet to the point of beginning.
