rights of survivorship, the following described real estate, situated in Shelby County,

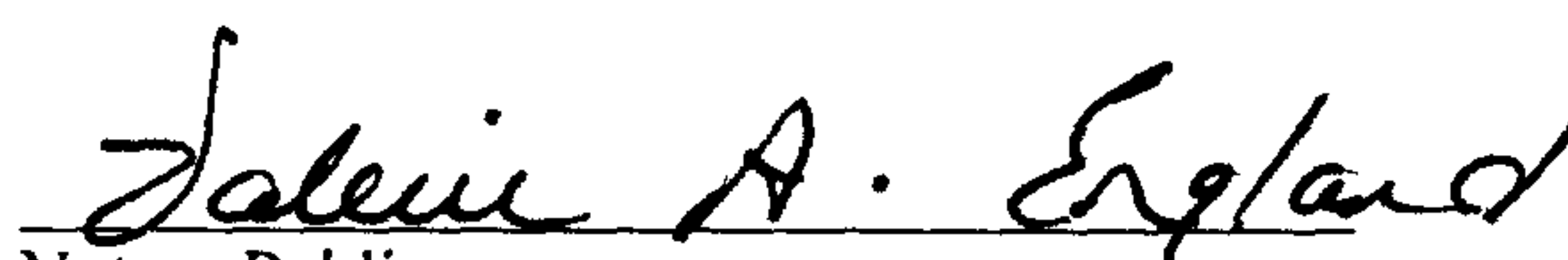
