MORTGAGE SUBORDINATION AGREEMENT

This Agreement Made in the City of **Birmingham**, County of **Shelby**, State of Alabama, on this **10th** day of **April, 2003** by and between First Federal Bank, and **Donald J Bratcher and Anamarie B Bratcher, husband and wife.**

W-I-T-N-E-S-S-E-T-H:

Donald J Bratcher and Anamarie B Bratcher is the owner of the following described real property located in **Shelby County**, to-wit:

LOT 8, ACCORDING TO THE AMENDED MAP OF MILL SPRINGS ESTATES 1ST SECTOR, RECORDED IN MAP BOOK 24, PAGE 116, IN THE PROBATE OFFICE OF SHELBY COUNTY, ALABAMA.

Whereas, First Federal Bank, is the owner of a mortgage recorded in Mortgage Book **2001** at Page **51898** in the records in the office of the Judge of Probate of **Shelby County, Alabama** covering the real property described above, and First Federal Bank is also the owner of the promissory note described in said mortgage, and,

Whereas, **Castle Mortgage** has made a loan on such premises and upon the condition that the said First Federal Bank shall subordinate the evidenced by the note and mortgage executed by **Donald J Bratcher and Anamarie B Bratcher.**

That First Federal Bank consents to and with **Castle Mortgage**, that the lien of it's mortgage as hereinabove referenced, is now, and shall continue to be subject and subordinate to the lien of the mortgage made to **Castle Mortgage** in the amount of **\$222,300.00** dated the 10th day of **April, 2003** and recorded in the Probate Office of **Shelby County, Alabama**, in Mortgage Book 2 Page 4. *20030418000238800
2. That this Agreement shall be binding upon and secure the parties hereto and their respective heirs, legal representatives, successors and assigns, and shall inure to the benefit of **Castle Mortgage**, it's successors and assigns.
