## **QUITCLAIM DEED**

WITNESSETH, That the said first party, for good consideration and for the sum of One Hundred and 00/100's Dollars (\$ 100.00 paid by the said second party, the receipt whereof is hereby acknowledged, does hereby remise, release and quitclaim unto the said second party forever, all the right, title, interest and claim which the said first party has in and to the following described parcel of land, and improvements and appurtenances thereto in the County of Shelby . State of Alabama to wit:

A parcel of land situated in the E½ of the SE¼ and part of the SW¼ of the SE¼ of section 22 and part of the SW1/4 of the NW¼ of section 23 and the NE¼ of the NE¼ of section 27. All located in township 19 South, range 2 East, Shelby County, Alabama, being more particularly Described as follows:
