Subject to restrictions, easements and rights of way of record.

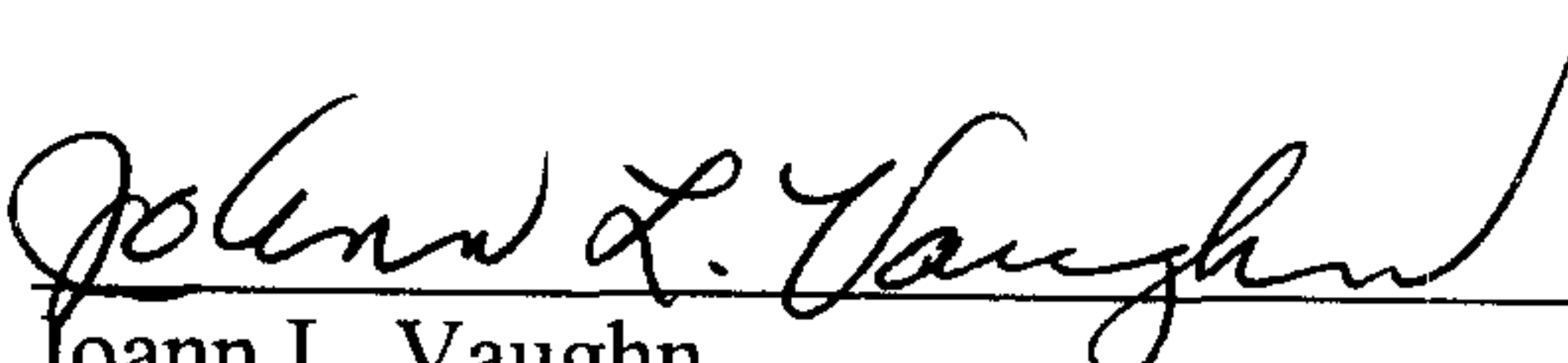
\$55,000.00 of the above recited consideration was paid from a mortgage recorded simultaneously herewith.

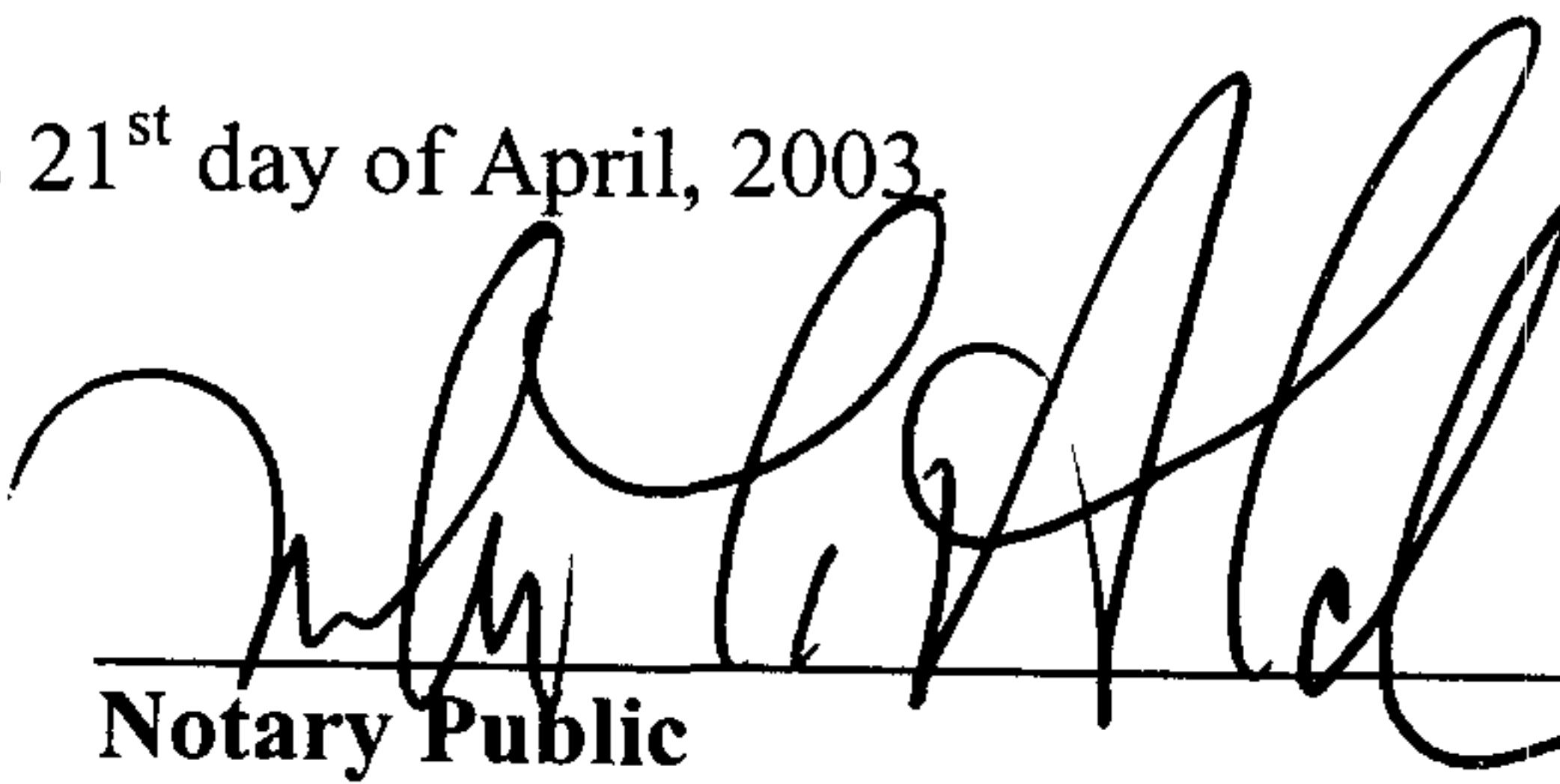
