

ARTICLES OF ORGANIZATION OF

PELHAM RETAIL INVESTMENTS, LLC

Pursuant to the Alabama Limited Liability Company Act (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Alabama, the undersigned hereby adopts the following Articles of Organization:

ARTICLE I

Name

The name of the limited liability company is *Pelham Retail Investments*, *LLC* (the "Company").

ARTICLE II

Duration

The Company shall have a duration from the date of organization until it is dissolved and its affairs wound up in accordance with the Act.

ARTICI F III

Purposes |

The purposes for which the Company is formed are:

- (a) To engage in any lawful business, act or activity for which a company may be organized under the Act, it being the purpose and intent of this Article III to invest the Company with the broadest purposes, objects and powers lawfully permitted a company formed under the Act;
- (b) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (c) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporation, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof; and

(d) To lend money, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be 713 Mill Springs Lane, Birmingham, Alabama 35244, and its registered agent at such address shall be Len Shannon for Shannon Investment Realty, LLC.
