THIS FORECLOSURE DEED made this 6th day of May, 2003, between JAMES JEROME GRUNDHOEFER and wife, LOU ANN GRUNDHOEFER, Parties of the First Part, and COMMERCIAL FEDERAL BANK, A FEDERAL SAVINGS BANK, SUCCESSOR TO COMMERCIAL FEDERAL MORTGAGE CORPORATION, Party of the Second Part;

W I T N E S S E T H:

WHEREAS, the said JAMES JEROME GRUNDHOEFER and wife, LOU ANN GRUNDHOEFER, heretofore executed COMMERCIAL FEDERAL MORTGAGE CORPORATION herein called the Mortgagee, a certain mortgage dated September 8, 1999, and recorded in Instrument No. 1999-38658, Probate Records of Shelby County, Alabama, which conveyed the hereinafter described property to secure the indebtedness evidenced by a note, payable in installments, therein described; and the Party of the Second Part was owner thereof at the time of the sale hereinafter mentioned; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and the Party of the Second Part thereafter gave notice by publication in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on the 9th day of April, 2003, and the 16th day of April, 2003, and the 23rd day of April, 2003, that it would sell the hereinafter described property before the front door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on the 6th day of May, 2003, and

WHEREAS, the said sale was held at the time and place stated in said notice which was published in the said issues of The Shelby County Reporter, and Party of the Second Part became the purchaser of the hereinafter described property at and for the sum of \$232,640.03 cash, which was the highest, best, and last bid therefor; and

WHEREAS, the undersigned, JAMES J. ODOM, JR., conducted said sale and acted as auctioneer thereat, under and pursuant to an appointment as such by the Party of the Second Part;

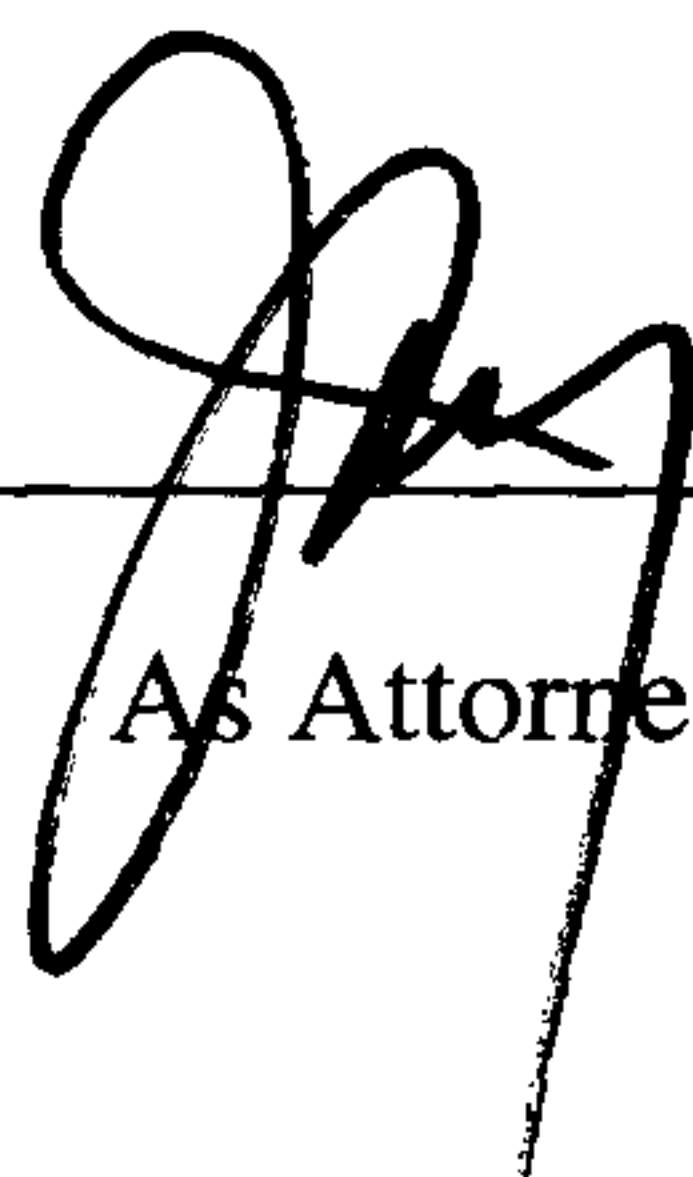
