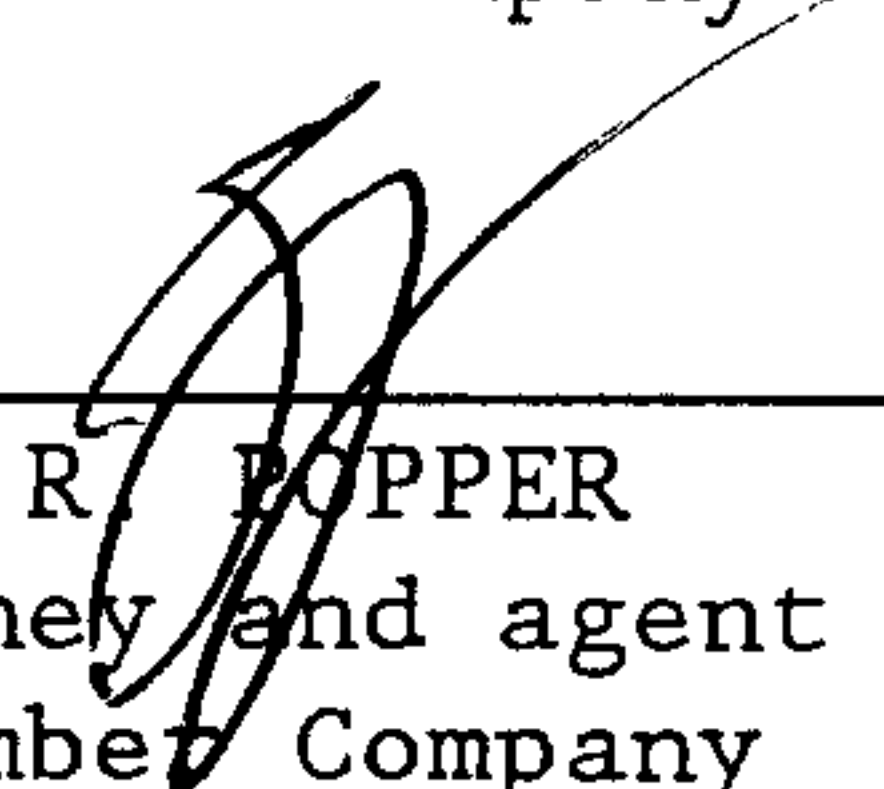

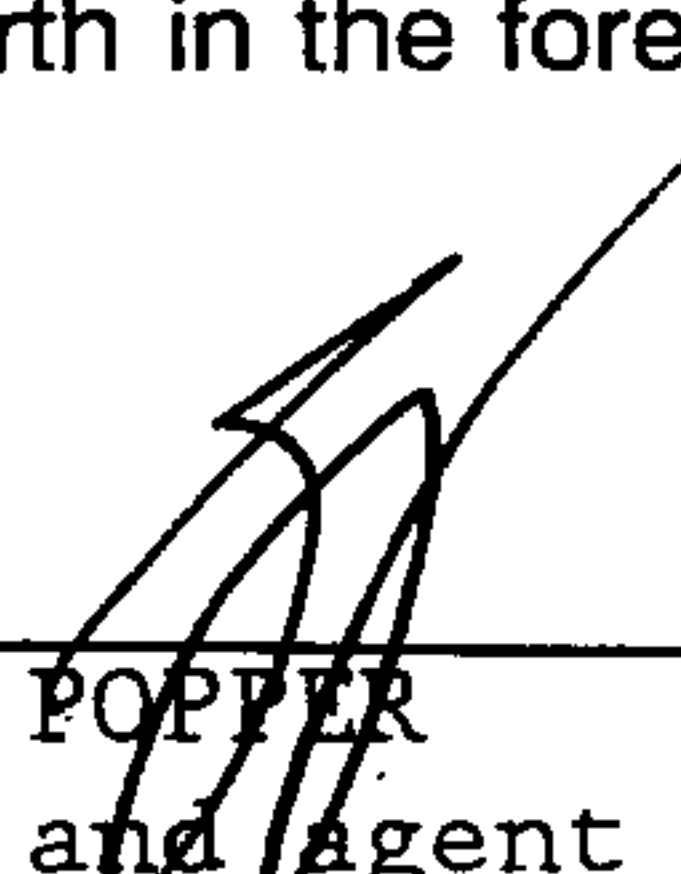
This sum of money is due and owing for building materials and related materials and/or labor, said materials and labor being used in the erection of improvements on the above described property.
