

#### ARTICLES OF ORGANIZATION

# American Landscape Services, L.L.C.

Pursuant to the Code of Alabama, § 10-21-0, et seq., the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

### **ARTICLE I**

## **NAME**

The name of the Limited Liability Company shall be "American Landscape Services, L.L.C."

#### **ARTICLE II**

### **DURATION**

The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Judge of Probate for Jefferson County, Alabama until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization, or,
- Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

### **ARTICLE III**

### **PURPOSES**

The Limited Liability Company has been organized for the following purposes:

To operate, conduct and maintain a business engaged in landscaping and to engage in any lawful business permitted under Alabama law as may be agreed upon by the Members.

#### **ARTICLE IV**

#### ARTICLE VII

#### ADDITIONAL MEMBERS

The members may permit the admission of additional members upon the unanimous consent of all the members of the company.

### **ARTICLE VIII**

## DISASSOCIATION

The disassociation of any member shall constitute a dissolution event, unless the business of the company is continued upon the written consent of all of the remaining members within ninety (90) days after such disassociation and/or there are at least two remaining members, or at least one remaining member and a new member is admitted.
