**ELEVENTH AMENDMENT TO
CERTIFICATE AND LIMITED PARTNERSHIP AGREEMENT**

The undersigned, desiring to amend the Certificate and Limited Partnership Agreement (the "Certificate") of CHELSEA FARM PARTNERSHIP, LTD. (the "Partnership"), dated as of July 30, 1993, and as heretofore amended, does hereby make, sign and file the following Eleventh Amendment to the Certificate as of January 1, 2003. Unless otherwise indicated, all capitalized terms used herein shall have the meanings ascribed thereto as set forth in the Certificate.

1. The name of the Partnership is Chelsea Farm Partnership, Ltd.
2. The Certificate was filed on August 5, 1993 in the office of the Judge of Probate of Shelby County, Alabama as instrument 1993-23134.
3. On January 1, 2003, Laurence D. Weygand transferred a one percent (1%) limited partnership interest in the Partnership to each of Stacy Weygand Barnett, Christopher B. Barnett, Scott Laurence Weygand, Louis Raymond Weygand and Michelle K. Weygand.
4. The Certificate is hereby amended by deleting Section 2.02 thereof in its entirety and substituting in lieu thereof the following as new Section 2.02:

Section 2.02 - Partnership Interests

In consideration of their capital contributions, the Partners shall have the following percentage interests in the Partnership (individually a "Percentage Interest" and jointly the "Percentage Interests"):




