

CORPORATION FORM WARRANTY DEED
JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP

That, in consideration of \$ 167,300.00 to the undersigned Grantor, **AUTHENTIC BUILDING COMPANY, LLC**, in hand paid by the Grantees named herein, the receipt of which is hereby acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Brandon J. DeHaven and Laura Jeanne DeHaven (herein referred to as "Grantees") as joint tenants with rights of survivorship, the following described real estate, situated in Shelby County, Alabama, to-wit:
