KNOW ALL MEN BY THESE PRESENTS THAT in consideration of Forty-Five Thousand

and No/100 Dollars (\$45,000.00), and other good and valuable consideration, paid to the

undersigned grantor, Wild Timber Development, L.L.C., an Alabama limited liability company

("Grantor"), by P. D. Bailey Corp. ("Grantee"), the receipt and sufficiency whereof are hereby

acknowledged, Grantor does by these presents, grant, bargain, sell and convey unto the

Grantee the following described real estate situated in Shelby County, Alabama (the "Property"),

Lot 4, according to the Final Plat of Wild Timber, Phase I, as recorded in Map Book 31, at Page 59, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama
