KNOW ALL MEN BY THESE PRESENTS, THAT


Whereas, on the 3rd day of April, 2000 a decree was rendered by the Probate Court of said county for the sale of the lands, hereinafter described, and conveyed for the state and county taxes then due from **Margaret R. Stracner**, the owner of said land for the costs and expenses thereof and thereunder.

Stracner**, owner of aforesaid land, and all the right, title, interest and claim of the state and county on account of said taxes, or under said decree and to the following described lands, hereinafter referred to, to-wit: parcel ID# 58/04/06/14/0/001/036.001 described as: BEG 515' SE OF INT W LN NE1/4 & NE R/W CTRL OF GA RR TH NW 876' TH N 720' (S) TH SELY 590' (S) TH S 866' TO POB S14 T18S R01E AC 10.00 being situated in said county and state, to have and to hold the same, the said right, title and interest unto themselves the said **Annie Mae Cunningham and Walter Cunningham** and their heirs and assigns forever, but no right, title or interest of any reversioner or remainderman in said land is conveyed hereby.


