MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on to-wit: the 29th day of November, 2001, Michael Benjamin Evans, an unmarried man, executed a certain mortgage on the property hereinafter described to New South Federal Savings Bank as recorded in Instrument #2001-53445 in the Probate Office of Shelby County, Alabama; said mortgage being transferred and assigned to Chase Manhattan Mortgage Corporation by instrument recorded in Instrument #20030219000103040 in the aforesaid Probate Office.

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage, and the said Chase Manhattan Mortgage Corporation did declare all of the indebtedness secured by said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper published in Shelby County, Alabama, and of general circulation in Shelby County, Alabama, in its issues of April 16, April 23 and April 30, 2003; and

WHEREAS, on the 30th day of May, 2003, the day on which the foreclosure was due to be held under the terms of said notice, between legal hours of sale, said foreclosure was duly and properly conducted, and Chase Manhattan Mortgage Corporation did offer for sale and sell at public outcry in front of the Courthouse at Shelby County, Alabama, the property hereinafter described; and


WHEREAS, Robert Curry was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Chase Manhattan Mortgage Corporation; and


