FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of September, 2001, Tatyana Y. Glazkova, unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc, solely as nominee for GMAC Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 2001-40412, and


