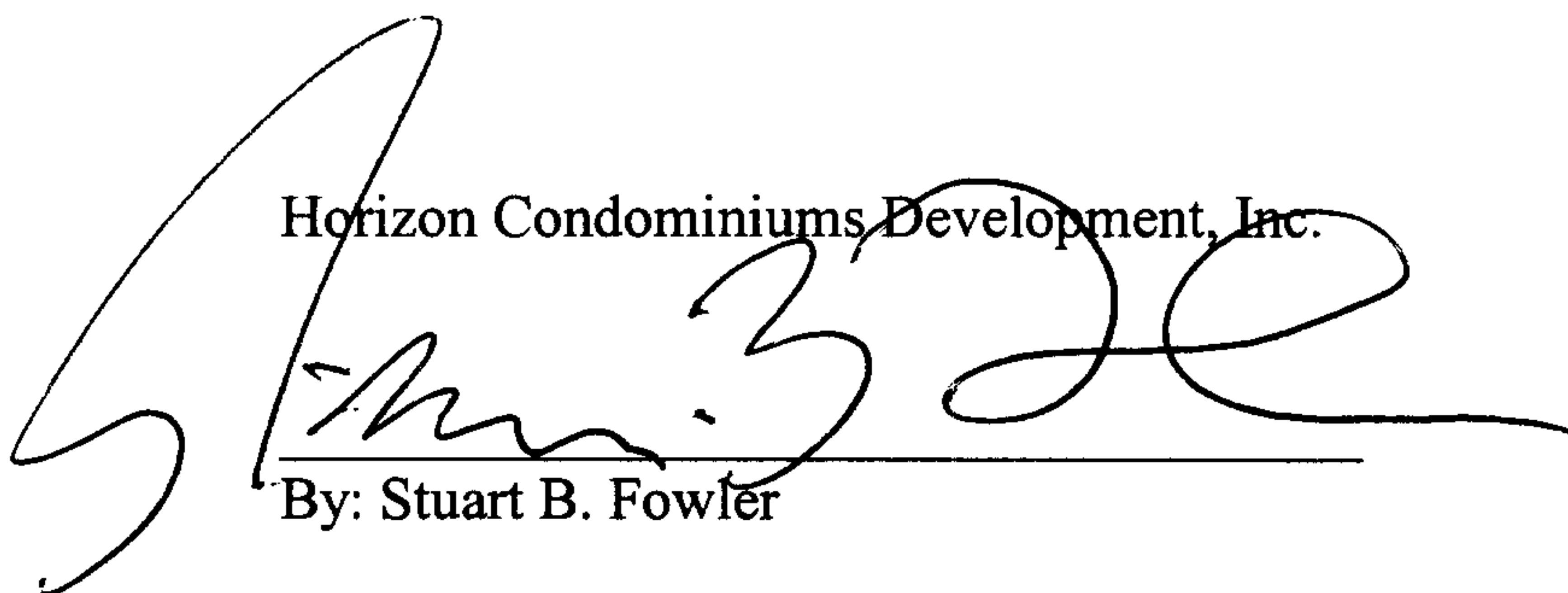
1. All rights of way, easements, covenants encumbrances, liens and restrictions of record.
