Smith and Laura H. Smith, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Arthur D. Gissendanner and Dale H. Gissendanner** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama, to-wit:**
