KNOW ALL MEN BY THESE PRESENTS, That in consideration of ONE HUNDRED AND NO/00 (\$100.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Frances Lokey Phelps, an unmarried woman and Mary Lokey Revis, an unmarried woman (herein referred to as grantor)** bargain , sell and convey unto, **Frances Lokey Phelps and Anne Lokey Phelps (herein referred to as grantees)**, the following described real estate, situated in: Shelby County, Alabama, to-wit:




Subject to taxes for 2003 and subsequent years, easements, restrictions, rights of way and permits of record.


