

SUBORDINATION AGREEMENT

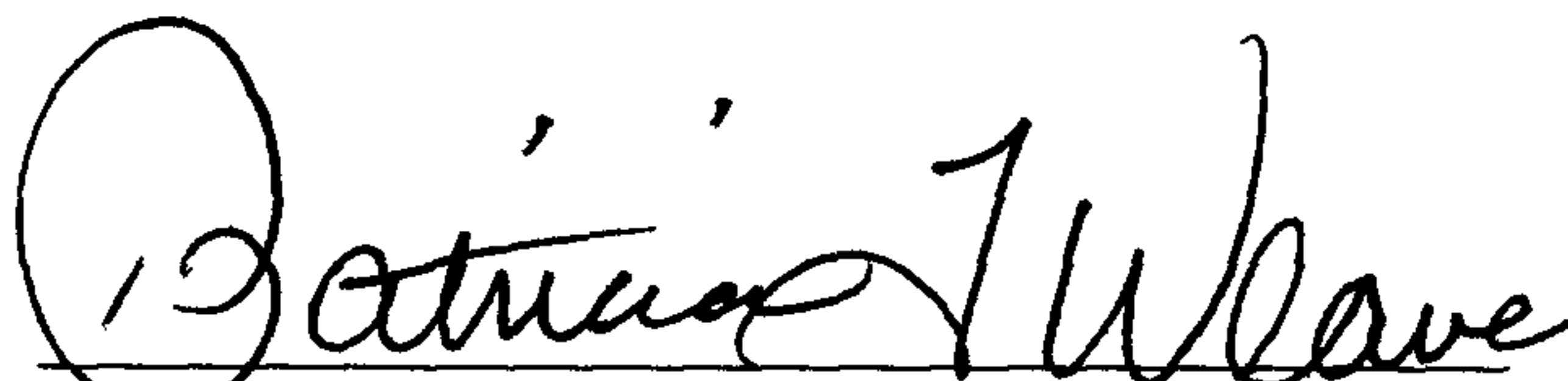

Both mortgages are encumbering certain real property described as:

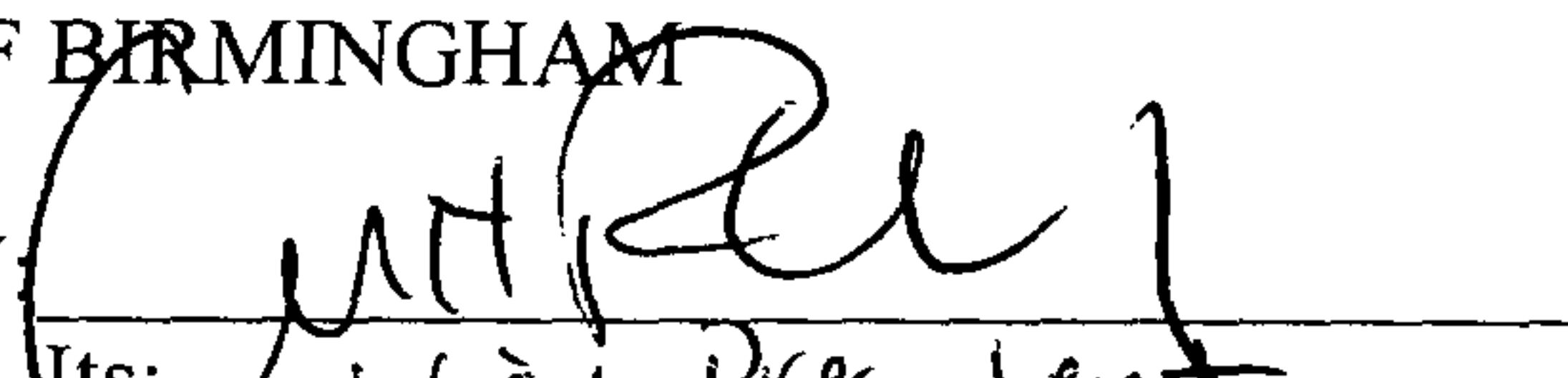
