MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on August 13, 1997, **James L. Dent, an unmarried man, Party of the First Part**, executed a certain mortgage to **Old Kent Mortgage Company**, which said mortgage is recorded in Instrument No. 1997-26056, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to Bank of America, N.A. successor by merger to BA Mortgage, LLC, Party of the Second Part; and

WHEREAS, default in the payment of the indebtedness secured by said mortgage, and Bank of America, N.A. successor by merger to BA Mortgage, LLC did declare all of the indebtedness secured by the said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in the Shelby County Reporter, a newspaper of general circulation in Shelby County, Alabama, in its issues of 6/4, 6/11, 6/18/2003; and

WHEREAS, on June 26, 2003, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of Shelby Resources Inc. in the amount of **ONE HUNDRED FORTY-SEVEN THOUSAND AND 00/100 DOLLARS (\$ 147,000.00)**; which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to Shelby Resources Inc.; and
