

FIRST AMENDMENT TO ARTICLES OF ORGANIZATION OF DANIEL ROSS CREEK, LLC

THIS FIRST AMENDMENT TO ARTICLES OF ORGANIZATION OF DANIEL ROSS CREEK, LLC (this "First Amendment") is made and entered into as of the 10th day of July, 2003 by Daniel Realty Company, an Alabama general partnership ("DRCO").

RECITALS:

DRCO is the sole member of Daniel Ross Creek, LLC, an Alabama limited liability company (the "Company"), which has been organized pursuant to Articles of Organization dated as of February 14, 2003 (the "Articles") and recorded as Instrument No. 20030220000107800 in the Office of the Judge of Probate of Shelby County, Alabama.

DRCO desires to change the name of the Company to Daniel Ross Bridge, LLC and to amend the Articles in order to reflect the name change to Daniel Ross Bridge, LLC.

NOW THEREFORE, in consideration of the premises and mutual promises, covenants and agreements hereinafter set forth, the parties do hereby certify as follows:

- 1. <u>Name of Limited Liability Company</u>. The original name of the limited liability company was Daniel Ross Creek, LLC (the "<u>Company</u>"). As provided in Paragraph 3 below, the name of the Company is being change to Daniel Ross Bridge, LLC.
- 2. <u>Date of Filing of Articles of Organization</u>. The Company was formed as an Alabama limited liability company pursuant to the Articles of Organization dated as of February 14, 2003 and recorded as Instrument No. 20030220000107800 in the Office of the Judge of Probate of Shelby County, Alabama.
- 3. Amendments. The name of the Company is hereby changed to "Daniel Ross Bridge, LLC".
- 4. <u>Full Force and Effect</u>. Except as expressly modified and amended herein, all of the terms and provisions of the Articles shall remain in full force and effect.
