

## EXHIBIT "A" LEGAL DESCRIPTION

A part of the NW 1/4 of the NW 1/4 of Section 29, Township 19 South, Range 1 East, situated in Shelby County, Alabama. Begin at the SE corner of the NW 1/4 of the NW 1/4 of Section 29, and run a tie line North 0 degrees 33 minutes East 400.00 feet; thence North 89 degrees 27 minutes West 154.6 feet; thence North 31 degrees 27 minutes West, 547.0 feet; thence South 65 degrees 52 minutes West, 50.4 feet; thence south 31 degrees 27 minutes East, 341.3 feet to the true beginning point of survey; thence South 31 degrees 27 minutes East, 130 feet; thence South 58 degrees 33 minutes West 165.0 feet; thence North 12 degrees 55 minutes West 137.2 feet; thence North 58 degrees 33 minutes East 121.4 feet to the true beginning point of survey.
