Commence at the SW corner of the SW ¼ of the SE ¼ of Section 13, Township 21 South, Range 3 West, for the point of beginning: thence run Northwardly along the West line thereof for a distance of 821.75 feet; thence turn an angle to the right of 164 degrees 04 minutes 49 seconds for a distance of 558.10 feet to the Westerly right of way of Chestnut Circle, said point also being a point on a cul de sac having a radius of 50.0 feet and a central angle pertaining the left 114 degrees 00 minutes 22 seconds; thence run along the arc of said curve a distance of 99.49 feet to the point of reverse curve to the right; having a central angle of 42 degrees 50 minutes,and a radius of 25 feet; thence run along the arc of said curve a distance of 18.69 feet; thence run Southeasterly along the tangent of said curve a distance of 28.6 feet to the point of beginning of a curve to the left having a central angle of 33 degrees 00 minutes 22 seconds and a radius of 240.0 feet; run thence along the arc a distance of 138.25 feet to the end of said curve; thence leaving said right of way turn an angle to the right as measured from the chord of said curve 46 degrees 06 minutes 25 seconds and run a distance of 90.22 feet to the South line of said ¼ ¼ Section; thence turn an angle to the right of 80 degrees 44 minutes 04 seconds for a distance of 265.0 feet to the point of beginning; being situated in Shelby County, Alabama.
