KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Fifty-One Thousand Nine Hundred and 00/100 (\$151,900.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Tyler J. Findlay and Carla S. Findlay, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Natalie Orona and George Baldwin**, single individuals (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of SHELBY, State of Alabama, to-wit:

Subject to existing easements, current taxes, restrictions and covenants, set-back lines and rights of way, if any, of record.

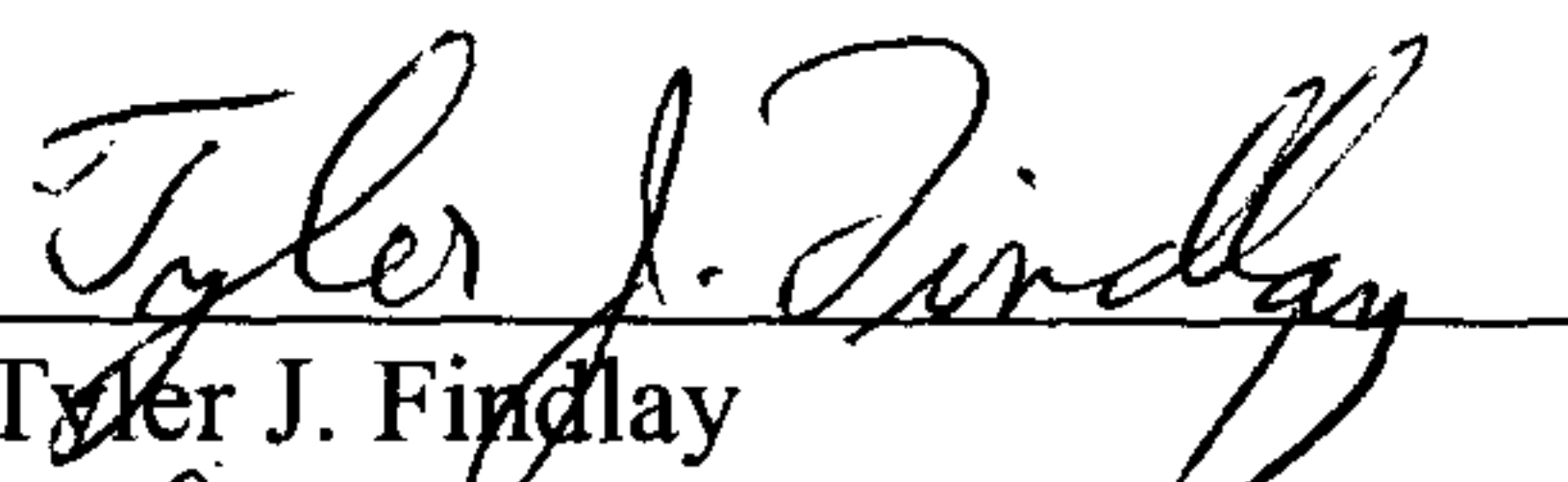
\$151,900.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

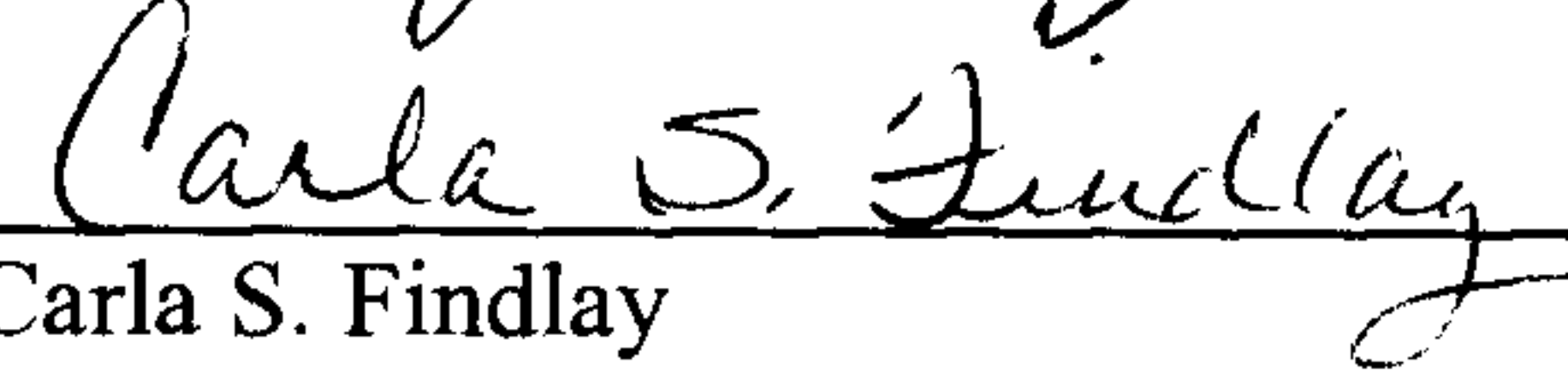
THIS DEED IS BEING RE-RECORDED TO CORRECT THE GRANTEES MARITAL STATUS.
