KNOW ALL MEN BY THESE PRESENTS, that in consideration of Four Hundred Seventy Seven Thousand Two Hundred Fourteen Dollars and 10/100 (\$477,214.10) Dollars and other good and valuable consideration to the undersigned, Monta Standridge, and wife Emma Lee Standridge, herein referred to as Grantors, in hand paid by Hewitt L. Conwill, and Joel C. Watson, herein referred to as Grantee, the receipt of which is acknowledged, the said Grantors do hereby grant, bargain, sell and convey unto the Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:

Sellers transfers any and all mining and mineral rights that they may own, if any.


