Know All Men by These Presents: That in consideration of **Forty six thousand nine hundred and no/100 (\$46,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Jimmy D. Harris and Theresa N. Harris, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **D. Karl Jones and Connie Jones** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

## EXHIBIT "A" LEGAL DESCRIPTION

Commence at the Southeast corner of the Northwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 24, Township 21 South, Range 3 West; thence run Northerly along East line of said  $\frac{1}{4}$ -1/4 for a distance of 1,333.25 feet to the Northeast corner of said  $\frac{1}{4}$ -1/4; thence turn an angle to the left of 125 degrees 33 minutes 32 seconds for a distance of 104.09 feet to the point of beginning; thence continue along last described course for a distance of 401.59 feet to the right of way of a public road; thence turn an angle to the right of 83 degrees 43 minutes 00 seconds and run along said right of way for a distance of 219.24 feet to the point of beginning of a curve to the right having a central angle of 79 degrees 46 minutes 18 seconds and a radius of 25 feet; thence run along arc of said curve for a distance of 34.81 feet to the end of said curve; thence continue along said right of way for a distance of 112.23 feet to the point of beginning of a curve to the right having a central angle of 34 degrees 06 minutes 51 seconds and a radius of 660.01 feet; thence run along arc of said curve for a distance of 392.97 feet to the end of said curve; thence turn an angle to the right as measured from chord of 107 degrees 03 minutes 25 seconds for a distance of 287.46 seconds to the point of beginning. Being in the Southwest  $\frac{1}{4}$  of Southeast  $\frac{1}{4}$  of section 13, Township 21 South, Range 3 West, Shelby County, Alabama.
