Roberts (12.5%) herein referred to as Grantee, the receipt of which is acknowledged, the said Grantors do hereby grant, bargain, sell and convey unto the Grantee, the following described real estate, situated in Shelby County, Alabama, to-wit:

Sellers transfers any and all mining and mineral rights that they may own, if any.



IN WITNESS WHEREOF, the undersigned Grantor has hereunto set his hand and seal this the 25th day of July, 2003.


