## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

SHELBY COUNTY ) KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Forty-Three Thousand Six Hundred and 00/100 Dollars (\$243,600.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**J. David Grill and his wife Michelle B. Grill**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**Steven W. Rauls and Claire J. Lane Rauls**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:


\$223,500.00 of the proceeds come from a mortgage recorded simultaneously herewith.

(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


