KNOW ALL MEN BY THESE PRESENTS, that in consideration of \$139,850.00 to the undersigned grantor, **NSH CORP. D/B/A SIGNATURE HOMES**, a corporation, (herein referred to as GRANTOR), in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR does by these presents, grant, bargain, sell and convey unto **JEREMY HOLLADAY and ELIZABETH W. HOLLADAY** (herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in the County of SHELBY, and State of Alabama, to-wit:

\$125,865.00 of the purchase price received above was paid from a first purchase money mortgage loan closed simultaneously herewith.


Subject to easements, restrictive covenants and ad valorem taxes of record.


