KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of One Hundred Forty-Eight Thousand and 00/100 (\$148,000.00) DOLLARS, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Keystone Building Co., Inc., a corporation** (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Autumn D.
