SUBORDINATION AGREEMENT

Shelby County) *Know All Men by These Presents That:*

WHEREAS, James D. Gullatte and Renda K. Gullatte (herein the "Borrower", whether one or more) owns certain real property situated in Shelby County, Alabama, which is more particularly described as follows, to wit:

Lot 8, according to the Survey of Southpointe, Fifth Sector, as recorded in Map Book 13, page 120, in the Probate Office of Shelby County, Alabama.
(Herein the "Property"); and

WHEREAS, SouthTrust Bank is the present holder and owner of a mortgage lien on the Property executed by James D. Gullatte and Renda K. Gullatte in favor of SouthTrust Bank, dated the 22nd day of November, 2002 with the credit limit of \$35,000.00, and recorded in Instrument No. 20021218000633720, in the Probate Office of Shelby County, Alabama, (herein the "Prior Mortgage"); and

WHEREAS, the Borrower is desirous of obtaining an additional mortgage loan from Southeastern Mortgage of Alabama, LLC (herein the "Lender") in the amount of \$192,000.00 to be secured by the Property; and

WHEREAS, the Lender is unwilling to take a lien on the Property subject to the Prior Mortgage; and

WHEREAS, the Holder of the Prior Mortgage is, under certain conditions, willing to subordinate its lien to that of the Lender;

NOW THEREFORE, in consideration of the premises and Ten Dollars (\$10.00) and other good and valuable considerations in hand paid to the Holder of the Prior Mortgage, the receipt and sufficiency of which is hereby acknowledged, the Holder of the Prior Mortgage has agreed to and by these presents does waive the priority of the lien of the Prior Mortgage insofar as the following described mortgage is concerned, but not otherwise:

That certain Mortgage from James D. Gullatte and Renda K. Gullatte to Southeastern Mortgage of Alabama, LLC in the amount of \$192,000.00, which said mortgage is recorded subsequent to the date of this document (herein the "Subsequent Mortgage"); and

The Holder of the Prior Mortgage hereby consents to the subordination of the Prior Mortgage to the Subsequent Mortgage, and agrees that the Prior Mortgage shall be junior and inferior to the Subsequent Lien; and further

It is expressly understood and agreed that this Subordination Agreement shall not affect the lien of the Prior Mortgage other than as indicated herein, nor shall it affect or modify the obligations secured by the Prior Mortgage, and said obligation shall continue in force and affect until fully paid, satisfied, and discharged.
