

ARTICLES OF INCORPORATION OF JIJO / ENCOURAGERS, INC.

For the purpose of forming a corporation under the provisions of the Alabama Nonprofit Corporation Act, Section 10-3A-1, et seq, Code of Alabama, 1975, and any act amendatory thereof, supplementary thereto or substituted therefor (hereinafter referred to as the "Act"), the undersigned does hereby sign and adopt these Articles of Incorporation and, upon the filing for record of these Articles of Incorporation in the Office of the Judge of Probate of the county in which the initial registered office is established under Article V hereof, the existence of a corporation (hereinafter referred to as the "Corporation"), under the name set forth in Article I hereof, shall commence.

ARTICLE I.

NAME

1.1 The name of the Corporation shall be JIJO / ENCOURAGERS, INC.

ARTICLE II.

PERIOD OF DURATION

2.1 The duration of the Corporation shall be perpetual.

ARTICLE III.

PURPOSES, OBJECTS AND POWERS

- 3.1 The purposes and objects and powers of the Corporation are:
 - (a) To engage in any lawful business, act or activity for which a notfor-profit corporation may be organized under the Act, it being the purpose and intent of this Article III to invest the Corporation with the broadest purposes, objects and powers lawfully permitted a corporation formed under the Act.
 - (b) Without limiting the scope and generality of the foregoing, the Corporation shall have the following specific purposes, objects and powers:
 - (1) To organize and operate exclusively for charitable

- purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax law).
- (2) To operate a non denominational Christian ministry with services available to the general public.
- (3) To bring strength and unity to the family, two parent, single parent, and individuals, through conferences, seminars, counseling, etc., within the United States and internationally, which provide education, information and assistance with general and specific life issues and applications.
- (4) To equip people with the tools necessary for the challenge of positive growth, and to introduce them to the Plan of Salvation.
- (5) To do all such other things as may be necessary or convenient to achieve the foregoing purposes.

ARTICLE IV.

<u>MEMBERS</u>

The Corporation shall be organized on a nonstock basis and shall have no members initially. The directors of the Corporation may, through appropriate by-laws, prescribe qualifications at a later date for one or more classes of members of the corporation.

ARTICLE V.

REGISTERED OFFICE AND REGISTERED AGENT: PRINCIPAL OFFICE

- The location and mailing address of the initial registered office of the Corporation shall be 117 Hicks Drive, Helena, Alabama 35080.
- 5.2 The initial registered agent at such address Martin Malizio.

ARTICLE VI.

INITIAL BOARD OF DIRECTORS

6.1 The number of directors constituting the initial Board of Directors shall be three (3).

ARTICLE VIII

INTERNAL AFFAIRS

- The following provisions for the regulation of the business and for the conduct of the affairs of the Corporation and the directors are hereby adopted:
 - (a) The initial bylaws of the Corporation shall be adopted by the board of directors. The board of directors shall have the sole authority to

- amend, repeal or alter the bylaws in whole or in part. The bylaws may contain any provisions of the affairs of the Corporation and directors not inconsistent with the Act or these Articles of Incorporation.
- (b) The business and affairs of the Corporation shall be managed by the Board of Directors. The number of directors comprising the initial Board of Directors shall be the number of persons listed as directors in Article VI hereof. Thereafter, the number of directors of the Corporation shall be fixed from time to time by the bylaws, or, in the absence of a bylaw fixing the number of directors, the number of directors shall be the same as the number comprising the initial Board of Directors. The number of directors may be increased or decreased from time to time by amendment to the bylaws, provided that the Board of Directors shall consist of not less than one natural person, and that no decrease shall have the effect of shortening the term of any incumbent director.
- (c) The Corporation reserves the right from time to time to amend, alter or repeal each and every provision contained in these Articles of Incorporation, or to add one or more additional provisions, in the manner now or hereafter prescribed or permitted by the Act.

ARTICLE IX

INTERNAL REVENUE SERVICE EXEMPTION STATUS

- 9.1 No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- 9.2 Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on:
 - (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue

law); and

(b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future federal tax law).

ARTICLE X

DISSOLUTION AND LIQUIDATION

10.1 Upon the dissolution of the Corporation, the board of directors shall, after paying or making provisions of the payment of all liabilities of the Corporation, dispose of all assets of the Corporation, exclusively for the organization or organizations organized and operated exclusively for charitable, education, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax law), as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of Shelby County, exclusively for such purposes or to such organization or organizations, as the Court shall determine, that are organized and operated exclusively for such purposes.
