

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF MT. SINAI MISSIONARY BAPTIST CHURCH (An Alabama Non-Profit Corporation)

All other provisions of the original Articles of Incorporation of said Corporation shall remain in full force and effect, without modification or amendment, except as hereinabove referenced.
