Know All Men by These Presents: That in consideration of **Two hundred thirty eight thousand and no/100 (\$238,000.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Randall W. Conforti and Carolyn R. Conforti, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Frances E. Salamone and Paschal J. Salamone** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:
