Know All Men by These Presents: That in consideration of **One hundred ninety nine thousand nine hundred and no/100 (\$199,900.00)** to the undersigned grantor, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Heatherbrooke Construction Company, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Dung K. Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.

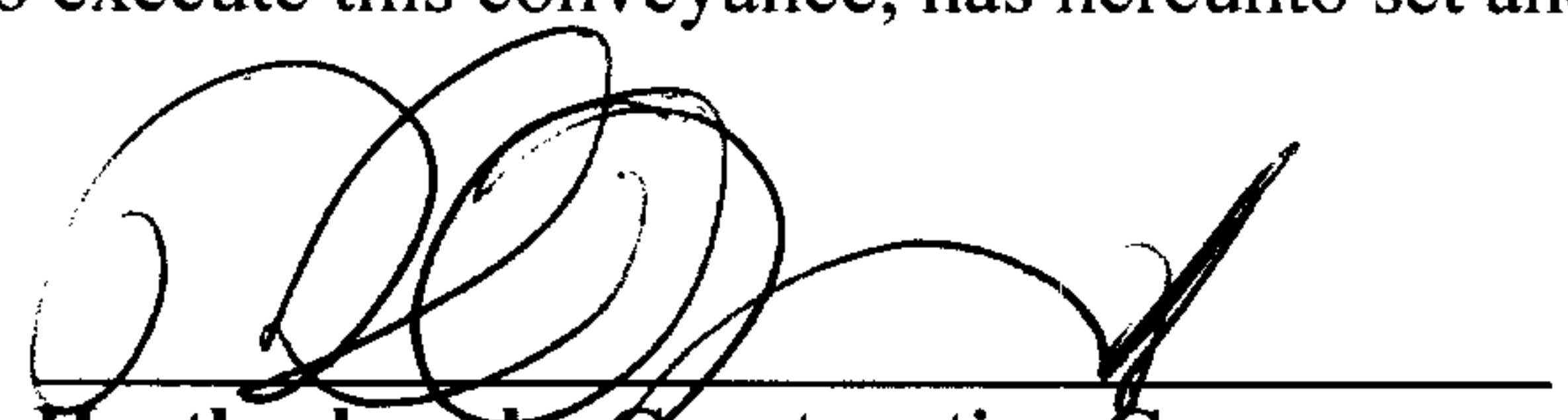
\$159,920.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

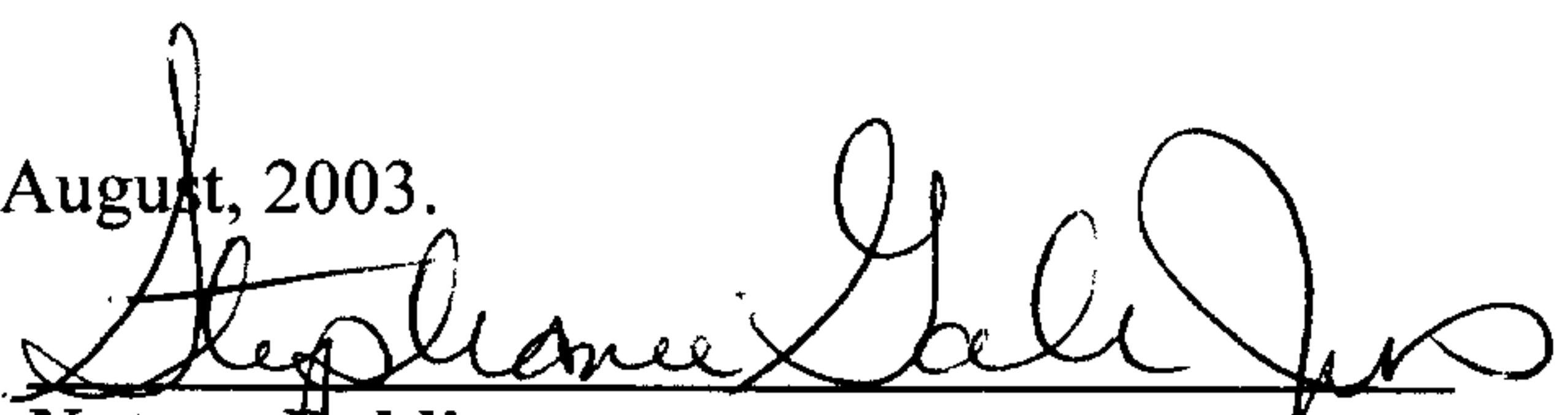
