Part of the SE ¼ of Section 9, Township 21 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

From the NW corner of the NW ¼ of the SE ¼ of said Section 9, run in an easterly direction along the north line of said SE 1/4 for a distance of 1266.24 feet to an existing iron pin being the most northerly corner of Lot 415, Lake Forest 4th Sector, as recorded in the Office of the Judge of Probate, Shelby County, Alabama, in Map Book 28, Page 93, and being the point of beginning; thence turn an angle to the right of 94°-54'-53" and run in a southerly direction along the east line of Lot 415 for a distance of 330.0 feet to an existing iron pin; thence turn an angle to the right of 49°-48'-25" and run in a southwesterly direction along the southeast line of Lot 416 of said subdivision for a distance of 310.00 feet to an existing iron pin; thence turn an angle to the right of 41°-18'-58" and run in a westerly direction along the southerly lines of Lots 417, 418 and 419 for a distance of 210.0 feet to an existing iron pin; thence turn an angle to the left of 53°-09'-51" and run in a southwesterly direction along the southeast line of Lots 419, 420, 421, 422, 423 and 424 for a distance of 315.0 feet to an existing iron pin; thence turn an angle to the left of 28°-47'-20" and run in a southwesterly direction along the southeast line of Lots 424, 425, 426, 427, 428, 429, 430 and 431 for a distance of 634.99 feet to an existing iron pin; thence turn an angle to the left of 17°-35'-29" and run in a southerly direction along the east line of Lots 431 and 432 of said Lake Forest 4th Sector for a distance of 150.0 feet to an existing iron pin being the northeast corner of Lot 308, Lake Forest 3rd Sector, as recorded in the Office of the Judge of Probate, Shelby County, Alabama, in Map Book 26, Page 143; thence continue in a southerly direction along last mentioned course and along the east line of said Lot 308 for a distance of 205.08 feet to an existing iron pin; thence turn an angle to the right of 17°-30'-43" and run in a southerly direction along the east line of Lots 309 and 310 for a distance of 237.21 feet to an existing iron pin; thence turn an angle to the right of 20°-09'-59" and run in a southwesterly direction along the east line of Lots 310, 311, 312, and 313 for a distance of 321.28 feet; thence turn an angle to the left of 126°-41'-49" and run in an easterly direction for a distance of 589.23 feet; thence turn an angle to the left of 46°-15'-06" and run in a northeasterly direction for a distance of 356.84 feet; thence turn an angle to the left of 54°-58'-20" and run in a northwesterly direction for a distance of 205.92 feet; thence turn an angle to the left of 88°-04'-14" and run in a southwesterly direction for a distance of 170.63 feet; thence turn an angle to the right of 64°-12'-51" and run in a northwesterly direction for a distance of 258.82 feet; thence turn an angle to the right of 65°-31'-28" and run in a northeasterly direction for a distance of 209.82 feet; thence turn an angle to the right of 9°-2'-51" and run in a northeasterly direction for a distance of 237.80 feet; thence turn an angle to the left of 21°-53' and run in a northerly direction for a distance of 438.09 feet; thence turn an angle to the right of 32°-42'-03" and run in a northeasterly direction for a distance of 334.86 feet; thence turn an angle to the right of 4°-35'-24" and run in a northeasterly direction for a distance of 303.03 feet; thence turn an angle to the right of 7°-05'-46" and run in a northeasterly direction for a distance of 267.02 feet; thence turn an angle to the left of 54°-33'-12" and run in a northerly direction for a distance of 175.0 feet, more or less, to a point on the north line of said SE 1/4 of said Section 9; thence turn an angle to the left of 94°-55' and run in a westerly direction along the north line of said SE ¼ of said Section 9 for a distance of 463.0 feet, more or less, to the point of beginning. Containing 20.89 acres, more or less.
