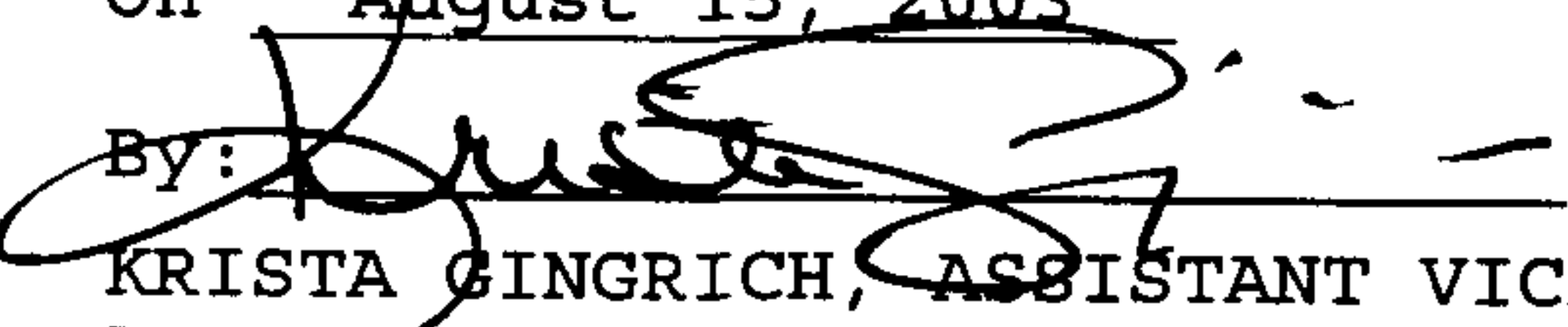

said Security Instrument and Note.

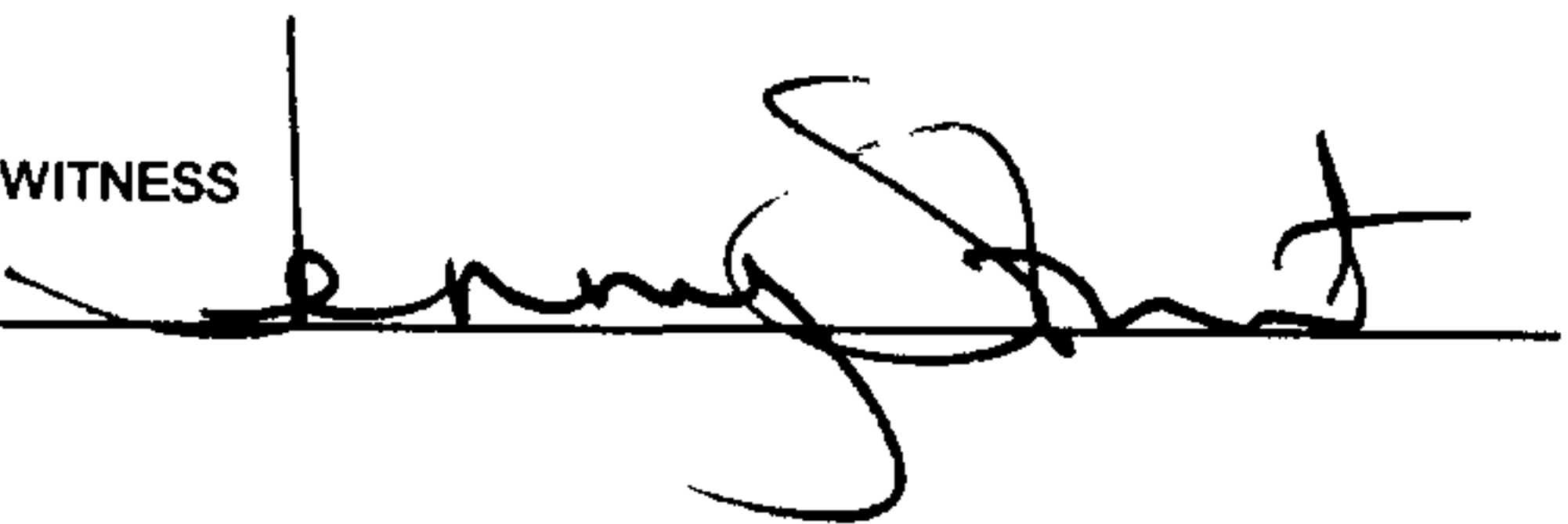

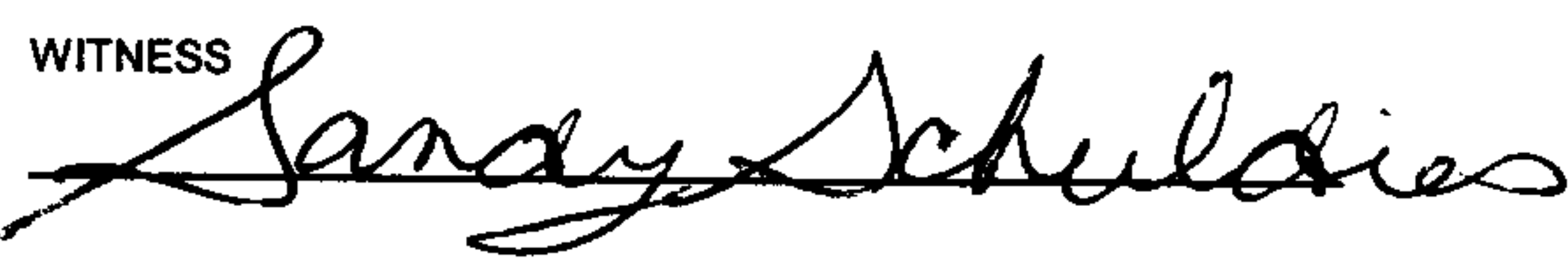

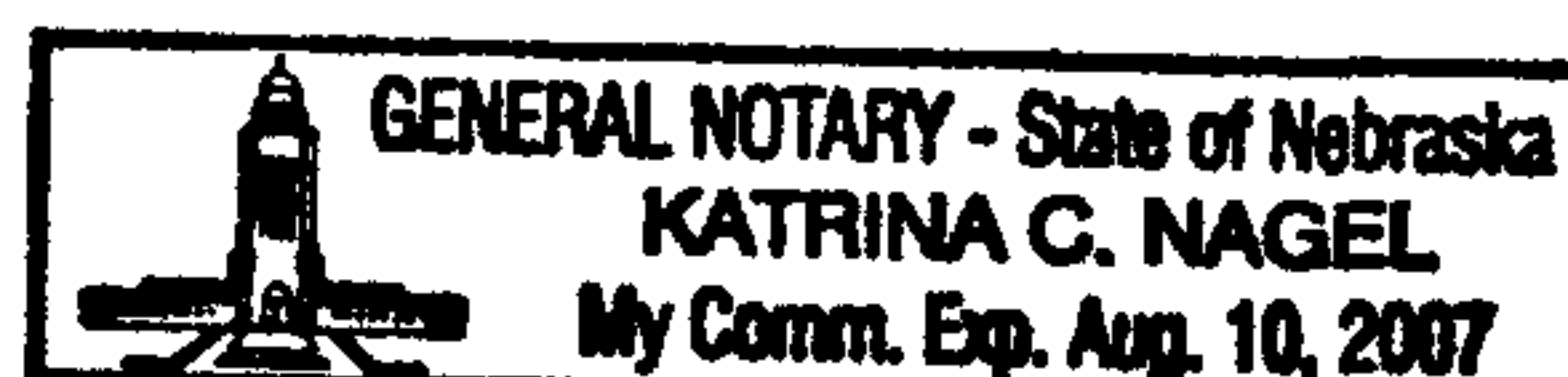
