SUBORDINATION OF EQUITY LINE OF CREDIT MORTGAGE

COMPASS BANK ("Compass"), for good and valuable consideration, does hereby acknowledge and agree that the lien of that certain Equity Line of Credit Mortgage dated JANUARY 22, 1998 from RAYMOND G. WATTS and FIONNA M. WATTS, as mortgagor (the "Mortgagor," whether one or more), to Compass, as mortgagee, recorded in the office of the Judge of Probate of SHELBYCounty, Alabama at Mortgage Book 1998 Page 4759, (the Equity Line Mortgage), shall be and hereby is subordinate in right of priority to the lien of that certain mortgage from that Mortgagor, as mortgagor, to COMPASS BANK, as mortgagee (the "Mortgagee"), to be recorded in the office of the Judge of Probate of SHELBYCounty, Alabama (the "Superior Mortgagee"); provided,, however, that such subordination shall be effective only to the extent that the Superior Mortgage secures that certain loan from Mortgagee to Mortgagor in the principal amount \$110,000.00 (the "Loan"), together with interest on the Loan and any amounts specifically secured by the Superior Mortgage which are expended by the Mortgagee to protect or enforce the Mortgagee's rights under the Superior Mortgage with respect to the loan ("the Superior Indebtedness"). The lien of the Equity Line Mortgage shall be superior in right of priority to the lien of the Superior Mortgage to the extent that the Superior Mortgage secures any indebtedness of the Mortgagor to the Mortgagee other than the Superior Indebtedness.

To induce Compass to enter into this Subordination Agreement, Mortgagee hereby certifies to Compass as follows:

- (1) that the proceeds of the Loan shall be used to satisfy in full all indebtedness secured by that certain mortgage dated MARCH 01, 1996, from RAYMOND G. WATTS and FIONNA M. WATTS, as mortgagor, to COMPASS BANK, as mortgagee, recorded in the office of the Judge of Probate of SHELBY County, Alabama at Mortgage Book 1996, Page 17609;
- (2) that the Loan shall bear a(n)FIXED interest rate of 5.25 % per annum and shall be repayable in monthly installments at a(n) FIXED amount of \$1,180.21, beginning OCTOBER 01, 2003 and continuing until SEPTEMBER 01, 2013, and
- (3) that the street address of the real property to be covered by the Superior Mortgage is 2940 CLYDEBANK CIRCLE, BIRMINGHAM, Alabama 35242.

The provision of this Subordination Agreement are solely for the benefit of Compass and Mortgagee, and shall not be deemed to modify any of the agreements executed and delivered in connection with the Equity Line Mortgage or the Superior Mortgage or to waiver any of the rights of Compass or Mortgagee, as the case may be, thereunder, as against the Mortgagor, nor shall it constitute or give rise to any defense, right of offset or counterclaim by Mortgagor.
